**Artwork will be dropped off and picked up at the AAWS office, Staff will move the work to and from the exhibition space.**

**ELIGIBILITY:** Works in all fine art media completed within the last 5 years are eligible. Art should be original (no mass-produced prints or reproductions). Hand-pulled prints, original digital prints and photographs are acceptable. Work must be artist's own creation – not done under the supervision of an instructor.

**PRESENTATION:** Framed work may not exceed 42 inches in any dimension. All works must have gallery quality framing and wire for hanging. Canvas edges must be finished or framed with no visible staples or unpainted canvas. If your work does not conform to the above guidelines, please feel free to contact AAWS staff for further guidance.

**Sales:** Artists set their own prices. Artist receives 70% of the sales price; AAWS retains a 30% commission. North Carolina sales tax is added to the sales price. If your work is not for sale, please include the insurance value.

**Promotional Images:** AAWS will use up to three images to represent the exhibit in Arts Council and our own promotions. If you would like to submit your work for consideration, please email a high resolution image of the piece with your note of intent email and written permission for us to use it for such. **For 2-D work, images must include only the artwork itself, with no framing or background.**

**Inventory Sheet and Art Label** is below and on the next page. Please fill out the attached Inventory Sheet completely with information exactly as you wish it to appear on wall label and bring with you when you deliver your artwork. Affix art label to the back of your entry.

**INSURANCE:** AAWS will take every reasonable precaution to prevent loss of or damage to your work but will not be responsible for any loss or damage. AAWS holds insurance for accepted works while in storage at The Rhodes Center and for the duration of the show, but not during transportation. If work is not for sale, let us know the insurance value. Works brought before or left after designated dates are NOT covered by insurance.
