## CALL FOR ARTISTS

---

The **WINSTON-SALEM ALL-CALL** is an inclusive visual arts exhibition open to all practicing artists in Winston-Salem and surrounding areas. Artists may bring two pieces, one piece will be selected by a jury of AAWS exhibitions committee members, providing it meets eligibility requirements for the exhibition. Please deliver your works to the Milton Rhodes Center for the Arts at 251 N. Spruce St. Winston-Salem, NC 27101. Bring your work with the inventory card, attached labels, and entry fee on the "Drop - off" date(s). There is a finite amount of wall space, we will stop accepting entries when we run out of space.

**Entry Fee Per Artist: \$10 or become a member of Associated Artists of W-S and enter for free!**

## ELIGIBILITY

---

**Any active artist working in or around Winston-Salem is invited to display their work.** AAWS and the Arts Council reserve the right to refuse artwork that does not conform to the listed eligibility requirements.

- No work may exceed 50 inches horizontally and weigh no more than 50 lbs.
- Canvases must be framed, or gallery wrapped. Canvases should have painted sides unless it is a necessary aesthetic choice by the artist.
- Works on paper must be protected by glass or Plexiglas.
- All 2-D work must be wired and ready to hang safely.
- Artwork should be themed for a family space and any artwork that is deemed inappropriate for the space will be disqualified for display.
- 3-D artwork must be ready to hang or sit on a flat surface.
- Installation art must be approved by gallery staff.

## SALES AND COMMISSION

---

**Artists set the sales price if they wish to sell their work.** It is not mandatory that all works are for sale. The artist will receive 70% of the price and AAWS will retain 30%. North Carolina sales tax is added to the sales price. All sales will be handled by AAWS staff.

## PROMOTIONAL IMAGES

---

AAWS will use up to three images to represent the exhibit in event promotions. If you would like to submit your work for consideration, please email a high-resolution image of the piece with your note of intent email and written permission for us to do so.

## HOW TO ENTER

---

To enter, please email a note of intent to [Bhauser@associatedartists.org](mailto:Bhauser@associatedartists.org) by September 28 with "W-S ALL CALL" in the subject line.

Please include the following in your email

- Your Name
- Titles of your entries
- The medium of your artwork
- Dimensions of your entries
- Prices or insurance value if your work is not for sale
- (optional) Images of your work for promotional use

You will receive a confirmation email within 48 business hours. If you do not, please contact our office at (336) 747-1463 to confirm receipt. If you do not have access to email, you can call - in your information.
